41 States	41 of 50 US states follow the standard CMS guidelines for tamper resistance. The nine other states have additional requirements as listed below. California	CA approved printers must apply the following features to the base stock, which must be chemically reactive. - Thermochromatic ink and a white opaque area must be applied to front of sheet. - Watermark must read "California Security Prescription" on backside. - All security features must be listed on backside.	California state scripts require customization. Call for more information.
Florida	All DocuGard medical papers can be used, but the printer must imprint all information in blue ink.	DocuGard medical security items meet requirement for Florida, but printer must imprint in blue ink.
Indiana	IN approved printers must apply the following features to the base stock: - An opaque symbol on front side must disappear if the prescription copy is lightened. - Watermark must read "Security Prescription" on backside.	Indiana state scripts require customization. Call for more information.
Kentucky	KY approved printers must apply the following features to the base stock: - Background of script must be printed in green ink. - Watermark must read "Kentucky Security Prescription" on backside. - An opaque Rx symbol must be in the upper right corner, 1/8" from top of prescription blank and 5/16" from right side of prescription blank. The symbol must be 3/4" of an inch in size and disappear if prescription copy is lightened.	Kentucky state scripts require customization. Call for more information.
Maine	ME approved printers must apply the following feature to the base stock: - Thermochromatic ink with Rx symbol.	DocuGard advanced items 04543 and 04548 are compliant in Maine.
New Jersey	NJ Law requires all scripts be consecutively numbered with pre-printed batch number and official prescription's serial number and bar code. The License Number and NPI# must be printed for each doctor listed. The prescribing area of the front side contains an "Rx" graphic in a rectangle. Microtext printing must be used so that if magnified can be seen as words. State seal must be on front and back for pantograph with bleed on all four sides." Doctor names must be printed on front in font no smaller than 7pt. Imprint format must contain: the practice name, up to three (3) doctors names, license number, NPI number and (optional) DEA Number, address and telephone number.	Must be an approved security printer for the state of New Jersey in order to print scripts.
New York	Prescription paper in NY must be obtained from the State of New York.	There are no approved printers for State of New York.
Texas	TX approved printers must apply the following features to the base stock: - Control number must be located in the uppermost portion of the form. - Thermochromatic ink heat must reveal the word "Safe."	Texas state scripts require customization. Call for more information.
West Virginia	WV approved printers must apply the following features to the base stock: - Background of script must be printed in pantone green ink. - Security features listed on the front of the sheet. - Watermark must read "West Virginia Prescription Security" on backside.	West Virginia state scripts require customization. Call for more information.
